



## ITC TELECOM AND DEAN E. ANDERSON SCHOLARSHIP TERMS AND CONDITIONS

1. One \$700.00 scholarship will be awarded to a graduating senior from each of the twenty-three school districts serving various segments of the ITC Service Area. Scholarship applicants and/or their parents or guardians must maintain at least one of ITC services (Telephone, Broadband Internet, or Cable Television services) and plan to attend a post-secondary institution located in either **South Dakota or Minnesota**.
2. Completed applications must be submitted to the respective High School Principal/Counselor for review by **March 3rd**. All applications can either be submitted by completing the on-line application found on the ITC Telecom Home Page, on a personal computer or by completing a paper copy of the application using a blue or black ink pen. **PENCILS SHOULD NOT BE USED**. If completed by personal computer, all applicants must recreate the ITC Application Form by including all information requested.
3. One \$700.00 scholarship will be awarded to a graduating senior that has elected to attend a school other than the school in the district in which he/she resides due to Open Enrollment. Open Enrollment status does not apply if the student attends a school that fits into Item 1. The parents or guardians must maintain at least one of ITC services (Telephone, Broadband Internet, or Cable Television services) for the student to be eligible for this scholarship. All applications for this scholarship will be reviewed and selected by management at ITC Telecom and the student(s) will be informed accordingly. All open enrollment applicants must submit their application by **March 3rd** to the office in Clear Lake, SD.
4. The respective high school official(s), as determined by each school district, will select the recipient from their school except in the case of the students involved in Open Enrollment whereas they will send the applications directly to the ITC Telecom office in Clear Lake, South Dakota. The High School official(s) must submit their selection and all other applications by **March 10th** to the office in Clear Lake, SD to provide ample time for notification to students and schools.
5. The recipients and schools will receive written notification after the ITC representatives have reviewed and approved the final selection. Recipients will be announced at the respective graduation exercises or awards banquets by school officials as well as recognized in the ITC Bell Ringer newsletter. *(Scholarship recipients are asked to please submit a photo for this newsletter.)*
6. The \$700.00 check to each recipient will be written at the appropriate time to apply towards the 2<sup>nd</sup> semester fees incurred during the freshman year and shall be made payable to the student and the institution attended. It is the responsibility of the recipient to notify **Jim Canaan at ITC, (605) 874-8338** or **[jim.canaan@itccoop.com](mailto:jim.canaan@itccoop.com)**, regarding proper names and the date the check is required at the institution.
7. Applicants are required to limit their information submitted to a total of five pages. Copies of awards and certificates need not be submitted, as there should be sufficient room to state these on the application form.
