#### ARTIFICIAL INTELLIGENCE UPDATE

The more I experiment and read about the artificial intelligence (AI) options available, the more interested I become in its possibilities. Sure, cautionary stories exist, like that of lawyers who entrusted AI to write their legal arguments, only to find themselves in trouble when the judge discovered that the cited court cases were fictional. Yet, amidst such tales, there are exciting examples of AI's potential to enhance our professional landscapes.

Al applications can be broadly categorized into two distinct approaches. The first, Al-generated content, which includes text, images, or translations conjured by Al tools. The second is Al-assisted content, where Al aids in brainstorming, refining, or doing things like grammar-checking material created by human hands.

At first glance, these two distinctions may seem similar. However, it might be easier to understand the differences if we consider the example of painting a picture or writing a story. If the content is Al-generated, the user gives the computer some ideas, and the computer creates the work. This would be like hiring an artist or author to create a piece.

On the other hand, if the content is Al-assisted, then the artist might use Al to get ideas for composing the painting, or the author might get help brainstorming the plot. Still, ultimately, it is the human, using their own skills and talents, who does the work of painting and writing. This would be like working with a mentor or trusted colleague and asking for feedback.

Artificial intelligence will likely make a greater impact on all our lives, whether or not we fully understand its implications. According to a recent Forbes article, a staggering 90% of surveyed business owners anticipate a positive impact from Al, foreseeing its use in improving customer service and generating content.

Of course, there are still many questions to answer regarding Al. Despite the incredible possibilities, we must consider the ethics involved. Some Al systems might favor certain groups over others, which isn't fair. There's also the worry about keeping our personal information safe. These tough questions need careful thinking and teamwork as we continue using Al to change the world.

Several options are available if you are eager to explore Al's potential. Other than ChatGPT, which has been previously discussed, there are also offerings such as Gemini and Microsoft Copilot, each offering unique functionalities and capabilities.

## **E-STATEMENT**

The E-Statement promotion is still going on! Sign up for Auto-Pay and go paperless with E-Statement now, and we will give you a one-time bill credit of \$20. The best part about signing up for both services is you never have to leave home to pay your bill or worry about being late. If you only sign up for one of these services, we'll still give you a one-time \$10 bill credit.

When you sign up for Auto-Pay, your monthly bill amount is deducted from your account. If you pay using your checking account, you can choose to have it deducted on either the 10th or the 17th of the month. If you pay with a credit or debit card, you can choose the date (from the 1st to the 17th of the month). Call ITC's offices at 1.800.417.8667 to sign up.

When you sign up for E-Statement and go paperless, ITC will notify you via email that your bill is ready each month. You can log in to see the information, save it, or print it if you want a paper record. To go paperless, sign in to www.itcebill. com/estatement/login and follow these instructions:

- 1. Log into E-Statement.
- 2. Go to "Settings" & click the "General" tab.
- 3. Under "Invoice Preference," choose "Web Bill Only."
- 4. Then click "Change Preference."

# MANDATORY 10-DIGIT DIALING COMING TO 507 AREA CODE

To ensure new telephone numbers are available, the Minnesota Public Utilities Commission approved the addition of a new 924 area code to the geographic region of the 507 area code. This process is known as an area code overlay. An overlay does not require customers to change their existing area code but does require using a new dialing procedure to complete calls.

Beginning August 30th, 2024, new telephone services may be assigned numbers with the new 924 area code.

ITC moved to 10-digit dialing for all exchanges effective on July 16, 2022. For the 507 area code, 7-digit dialing was still allowed. Beginning July 30, 2024, if you have a 507 area code you must dial the area code + telephone number on all calls, including calls within your same area code. If you do not dial the area code + telephone number, your call will not be completed, and a recording will instruct you to hang up and dial again, including the area code.
