This year's theme is Fiber Fest. This is an appropriate theme, considering we are now 100% fiber! It has been a long road that began in 2006, and now we can finally say that we have fiber to all our members. Thank you to everyone involved in making this happen.

In conjunction with Fiber Fest, ITC launched GIG service! We are excited to offer this Fiber-Fast speed to our members. For those who don't know, one GIG equals 1,000 Mbps. That's fast! In celebrating GIG service, we drew one month of free GIG service for ten winners! These winners will have GIG service turned up during the month of November. That's a GIG deal!

ITC is continuing its commitment to broadband in this region by expanding our fiber-optic network. The Board of Directors and staff understand that broadband is vital for economic development in our rural areas and strive to engineer expansions that benefit both the Cooperative and the recipients of the Fiber-Fast Internet options. We are currently working on expansions in Grant County and the Lake Poinsett/Lake Albert areas, as well as rural Codington County. Along with ITC's investment in the fiber-optic expansions, ITC also received funding from the Connect SD Broadband Grant Program and the FCC's Rural Digital Opportunity Fund (RDOF). The coverage map located in this edition of the Bell Ringer displays the expansions.

What a busy year we have had. I hope to see you all at the Annual Meeting on September 11, with registration starting at 9:30 AM. There will be a free gift for members and a lunch following the meeting. The first 25 kids will also receive a gift. Be sure to bring your registration card printed on page seven of this newsletter. # ITC IS 100% Fiber



Welcome everyone to the 34th Annual Meeting of ITC. I am Warren Brandlee, the President of the Board of Directors and the representative of District Seven, the Clark exchange. The Board and I are pleased to be able to meet in person again, so thank you all for attending.

This year was a very productive year for ITC. As stated at the 2018 Annual Meeting, ITC had a 2020 Vision to complete the fiber-optic upgrade to our members. This year, we are excited to report that we have completed this upgrade to our network to replace the aging copper cables. This upgrade adds reliability and redundancy to our network.

This summer we have been celebrating. Our Annual Meeting theme, Fiber Fest, is our way to celebrate that we have fiber-optics to 100% of our member locations. You may have seen ITC employees at parades or other events handing out shirts and frisbees.

With the goal of bringing fiber-optics to ITC's current membership within reach, the next goal was to look at areas where ITC could expand to reach potential locations that were considered underserved for broadband.

In 2020, we completed our fiber-optic build-out in Lincoln County, MN. This added the areas of rural Ivanhoe, rural Tyler, rural Minneota, rural Porter, some areas of rural Canby and Arco. In 2021, we set out to expand to areas of rural Grant County. This project is well underway, with the construction set to wrap up in the next couple of months with installations to follow. We are also excited to start a fiber-optic expansion for South Lake Poinsett and areas around Lake Albert. The construction for this area is expected to carry into next Spring.

To kick off 2022, we are also going to be launching a rural Codington County expansion. More information on these expansions is available on our website at www.itc-web.com/expansions.

ITC is fortunate to have a dedicated Board of Directors to keep ITC moving in the right direction. They are committed to helping guide the ITC management and staff in ways to meet our member's ever-changing needs. Thank you so much for your dedication to ITC.

I'd also like to thank the ITC employees. Their experience and dedication to the Coop have brought us to where we are today. Even with COVID-19, we have managed to move forward successfully to finish our fiber build. We will all continue to work hard on behalf of our members.

And lastly, I want to thank all of you for your patronage of this Cooperative! You are the reason we do what we do, and you are the ones who make all of this possible!



#### MINUTES OF THE VIRTUAL THIRTY-THIRD ANNUAL MEETING INTERSTATE TELECOMMUNICATIONS COOPERATIVE, INC. SEPTEMBER 19, 2020 - CLEAR LAKE, SOUTH DAKOTA

Warren Brandlee, President of ITC Board of Directors, called the 2020 Virtual Annual Meeting to order on Saturday, September 19, 2020, at 10:00 a.m. There were a total of 865 mail-in ballots received from members of the Cooperative.

The invocation was given by Director Cliff Ruesink.

Twenty \$50 cash prize winners will be selected on Monday and credited to their bills.

A quorum was found to exist for the virtual annual meeting, and therefore, the 33rd Virtual Annual ITC Meeting may proceed.

President Warren Brandlee read the Notice of Meeting and the Proof of Mailing.

President Brandlee declared that the 2019 Annual Meeting minutes were approved by the members' ballots.

President Brandlee gave his report regarding the 2020 year for the Cooperative via the September, 2020, issue of the Bell Ringer. The Cooperative's Annual Meeting is a bit different this year, because it is necessary to use Zoom software to connect for the annual meeting via the Internet. Twenty attendees will receive \$50 credit on their bills upon being drawn from the name of those who were present for the Zoom meeting. The theme for this year's Annual Meeting "Stream On" refers to the trend of streaming your video using the Internet. President Brandlee wanted to notify the members of the Cooperative regarding other options, including ITC's high-speed Internet, together with access apps such as Netflix, Disney Plus, and Hulu.

The crews for the Cooperative continue to work on construction projects for this year even with the pandemic. Pre-construction is nearing completion for the rural areas Bryant, Florence and Lake Norden. Rural Lake Benton will also be completed this fall. It is hoped that FTTH will be installed in all of the ITC service areas by the end of this year!

ITC is also working on a new project located in Lincoln County, Minnesota. The pre-construction for the FTTH is complete and the drops in this area are fiber ready. Numerous applications for services have been received and the crews will be doing installations this fall weather permitting.

Director Cliff Ruesink has announced his retirement from the Board of Directors. Director Ruesink is wished the very best in his retirement. District One will continue to be represented by Joel Brandt. President Brandlee also thanked the ITC employees and all of those attending the virtual annual meeting, because of the Covid-19 pandemic.

The Secretary's Report was given by Director Joel Brandt in the September, 2020, issue of the Bell Ringer. He noted that the Cooperative is completing its 2020 goal to be 100% fiber. Also, Secretary Brandt advised that Director Penny Krause ran unopposed in District Three, and likewise, Director Tom Main ran unopposed in District Five, plus Stephanie Sauder ran unopposed in District Six. There was a change this year by the Board of Directors regarding District One which includes Castlewood, Clear Lake, Estelline and Goodwin in that the number of Directors has been reduced from two to one as a result of Director Cliff Ruesink's retirement. Congratulations to Director Ruesink for his fifteen years of service and his retirement, and also, congratulations to the three Directors reelected. Director Brandt will continue to represent District One. The Pandemic has resulted in finding new ways to do our jobs, including this virtual Annual Meeting. Approximately half of the Coop's staff works from home thanks to the latest technology and super-fast ITC Internet. Our technicians are wearing masks and taking extra precautions to keep everyone safe. Obviously, the theme of "Stream

On" encourages management, employees and the directors to do the very best they can in providing our members with the best products and services possible during these extenuating circumstances. In the event you have any concerns or questions, then please contact your Director or you may call the ITC office for assistance. Thank you for attending this virtual Annual Meeting.

The Treasurer's Report was provided on page four of the September 2020 Bell Ringer. The financial statements for the Cooperative conclude as of March 31, 2020. The Balance Sheet increased by just over \$6 million. Your Coop was able to reduce debt in total by \$3.2 million, even as your Coop has aggressively constructed Fiber to the Home. Patronage Capital increased by nearly \$7 million. The Statement of Operations shows that Your Coop had a great year with a Net Margin of \$12,158,495. The Treasurer's Report was approved by the ballots mailed in earlier by the members.

Manager Bryan Roth advised that ITC has made it a priority to keep its employees and members safe since the beginning of the pandemic. ITC offices have been closed since March as a result of the pandemic. The Board of Directors decided that a virtual Annual Meeting would be the best alternative available under the circumstances, and accordingly, the annual announcements and ballots were mailed to each member for their participation in the meeting. Manager Roth advises that several changes to the Cooperative's by-laws were made as a result of the pandemic. ITC's services are essential in that its broadband service enables members to work from home, provide eLearning, and to communicate with family and friends, plus receive entertainment and news without leaving the safety of your home. Furthermore, ITC has provided numerous broad connections for eLearning to families who did not have broad service or could not afford it when our schools closed this past spring. This allowed the members' children to complete school assignments. The positive financial report included in the recent issue of the Bell Ringer is a reflection of the great team of employees and forward-thinking Directors. Manager Roth thanks the ITC team and the Directors for their dedication to the Cooperative. Manager Roth also gives thanks to Director Cliff Ruesink who is retiring from the Board. The Cooperative's vision to complete the construction of fiber to all our exchanges by the conclusion of 2020 appears to be imminent. The construction projects are on schedule and the fiber construction to all members will be completed this fall. The conclusion of the construction season results in over 1,200 miles of fiber installed in 2020. Finally, more than \$4.5 million of capital credits will be disbursed to members in December. Thank you for your support and understanding during these challenging times-stay safe!

President Brandlee introduced Attorney Todd Boyd and he explained to the members of the Cooperative that the Board of Directors made three changes to the By-laws regarding directors as allowed by the by-laws. The first change is in Article IV, Section 3 regarding an applicant being allowed to obtain signatures on their petition electronically. Also, in Article IV, Section 3 a second change was made to reduce the number of signatures required from 35 to 15. Third, the last change in the by-laws is in Article IV, Section 5 which reduces the number of directors representing District One from two to one.

President Brandlee asked if there was any unfinished business to come before the virtual Annual Meeting and there was none.

President Brandlee asked if there was any new business and there was none.

Motion was made by G. Todd Garry of Webster, SD, and seconded by Tristan Rabine of Strandburg, SD, to adjourn. Motion carried.
